Notes:

- (1) Seminars and other classes with no exams are not listed on this schedule.
- (2) Where an exam is scheduled for multiple rooms, the larger room is for ExamSoft and the smaller room is for Bluebooks unless the professor directs otherwise.
- (3) Students who have three final exams in three days may have the third exam moved to the next free exam day. Students needing to move exams for this reason must contact Kristi Wright about rescheduling their exams.
- (4) Take-home exams that are "self-scheduled" are not listed on this exam schedule. An exam is "self-scheduled" if the student may choose when to turn in the exam OR the exam has a fixed due date but the student has a week or more to complete the exam. Self-scheduled take-home exams do NOT count for the purposes of the "three exams in three days" rule. A list of classes with self-scheduled take-home exams is included at the end of this schedule.
- (5) Classes with take-home exams that are not self-scheduled (i.e. the due date is fixed and the student has less than one week to complete the exam) are listed on the exam schedule (marked with "TH") and ARE subject to the "three exams in three days" rule.
